

arcane procedures. When asked how much all this cost – building a stage, etc. He said, "I don't remember ever being assessed dues. Patrons probably just gave their pocket change." And, he said, "there never was any problem getting people to be officers." Vi Livingston (Grace's aunt) was always involved in one way or another. He remembers the Hill brothers (Harold and Don) always being at the picnics and involved. (Don Hill is the current Livingston-Watson Historian). John also took his turn as an officer many years ago.

John's wife Grace passed away in 1997 and rests at the Rock Church Cemetery. The annual memorial service, which always was a very important part of the service to John and Grace, has taken on even greater importance since then. The traditional service has remained the same for many years – which includes a short memorial message from one of Livingston's pastors and presenting a flower to the families that have lost a loved one during the year. In recent years John's granddaughter Lynnette Lorch and grandson Chris Fugate have performed musical numbers at the church. John's four daughters attend regularly and his daughter Barbara has been an officer for the last several years. John's girls, Elizabeth Lorch, (Ridgecrest, CA) Jeanne West (La Crosse, WI), Barbara Henning and Mary Tredinnick (both of Madison, WI) bring their families and feel the connection with their mother when visiting with relatives and friends from the past.

John has many memories and stories about the reunions and life in Livingston. There is usually a crowd around him listening and picking his brain about "historical" and sometimes, judging from the laughter, "hilarious" recollections.



Irish Breakfast Potatoes


32 oz. frozen hashbrowns
1 ½ c. grated cheddar cheese
1 c. sour cream
1 stick oleo
1 can cream of chicken soup
salt and pepper

<u>Livingston Watson Reunions - Past</u>

"When we were kids was the heyday of the picnics," says John Biddick, the record holder for the person who has attended the most Livingston Watson Reunions. John, who will be 79 at the 2002 picnic, said his mother brought him to the picnic in August 1923 when he was just a little more than 1 month old. That was the first reunion and his mother Delphia Biddick, whose maiden name was Graham and as John says, "was a Watson on the Waring side," would never have missed a picnic. He's proud that the only picnics he ever missed were while he was overseas during World War II.

John remembers having the most fun at the reunions when he was a young boy. He says he remembers going when he was 13 – in 1936 and having a great time. He said the activities would begin around dusk on Friday night when people from all over would start arriving. This was an annual homecoming for families from across the country. There would be cheerful welcomes, greetings and storytelling into the evening. He remembers many were teachers and they came from W. Virginia, Ohio, California and even Canada. There would be supper in the park and great anticipation for the weekend to come.

Saturday was the big day. There was a memorial service that was held right in Livingston Park. There are two memorial stones located in the park, the larger of the two is a memorial for the veterans of World War I, and a smaller stone recognizes Johnny Watson, a Livingston Veteran. Johnny died in WWI when he drowned in a harbor in France (Johnny was a 1st cousin to John's mom, Delphia) he would have been just about 20 years old. This of course was the perfect location for a memorial service for the Livingston Watson reunion. John said the memorial service held at the Rock Church Cemetery is a tradition that began in later years. He believes it was Vi Livingston that started it.

The rest of the day and into the evening was reserved for lighter fare. He remembers Claude Watson — his future father-in-law, organizing everything: bands on the bandstand, skits, and contests for dramatic storytelling. "Why the town people even built a stage every year for these purposes," said John. "They strung lights; it was a big deal." He said the picnic tables would be pulled together and filled with delicious food from the town ladies. Pasty was the number one item he recalled.

"The picnics were dry – there was never any alcohol," laughed John when asked if there was ever any beer at the picnics. "Why, in 1936 Livingston had only one tavern. Although prohibition was repealed in 1933 the Republicans wouldn't have it – it was a long fight before there were any taverns in Livingston yet alone drinking at the Livingston Watson reunion."

In later years he married his childhood sweetheart, Grace Audrey Watson. Grace was the daughter of Hannah Maude Livingston-Watson and Claude Watson. That of course sealed his continued pilgrimage to Livingston for the annual reunions.

John recalled when he attended the reunions as an adult the business meetings were sometimes a little "nasty." The hotly contested items were usually about the contents of the minutes or some

The Civilian Conservation Corps was created in 1933, as part of FDR's "New Deal" to get America back to work and out of the Great Depression. My father used to say about the Great Depression, "We had everything, but money. We weren't any poorer than the guy next door because we shared everything we had." We need to accept the fact that **the best way to take care of ourselves is to take care of our neighbor**. Remember the Golden Rule: "Do unto others as you would have them do unto you" - God calls all of us to this commitment!

Common Sense is another National treasure that seems to have been discarded. We have become a Nation run by current thoughts and trends. Politicians govern by public polls, psychologists influence every level of society with their latest scientific theory based on the last research report, and preachers get their sermons on the internet instead of their knees. We have too often adopted the slogan "Never do anything the easy way if there is a more complicated method available." In this age of "road rage" common courtesy has diminished right along with common sense. What we need is businessmen, educators, and homemakers who employ the timeless ethics and values of fair play, honest communication, and mutual respect for what is right. The Ten Commandments are still effective foundations for common sense.

As we observe the contributions made by various members of the Livingston-Watson families, we can also celebrate the common sense lessons of life that they have passed from one generation to the next.

Consistency is a character trait that has also lost its prominence lately. In this mobile society of corporate ladders, job transfers, and down-sizing it's getting harder and harder to stay in one place, doing one thing! The pursuit of wealth, happiness, and the American Dream has resulted in too much poverty, sadness, and nightmares because of the lack of consistency. There is much to be said for the family that can put down roots, share their faith, and have a lifetime of influence and benefits from working and playing in one community. What we need is for "bedroom communities" to wake up to the fact that there is no place like home! What we need to realize is that the best things in life are still free and can still be found in one's own backyard.

Each of us still have the opportunity to enlist in this Millenium's New Deal Triple C's of Commitment, Common Sense, and Consistency. It starts today and it starts with you!
